

How to activate your rapid! PayCard



On the main login screen, Select "Add or Activate your rapid! PayCard"



Enter the following:

- · The 16-digit card number
- · Expiration month and year
- Your DOB
- The CVV (from back of your card)
- Your SSN



Update your phone number and your email address and press "Continue"




Your rapid! PayCard should now be successfully activated and you will receive a welcome email with login information
